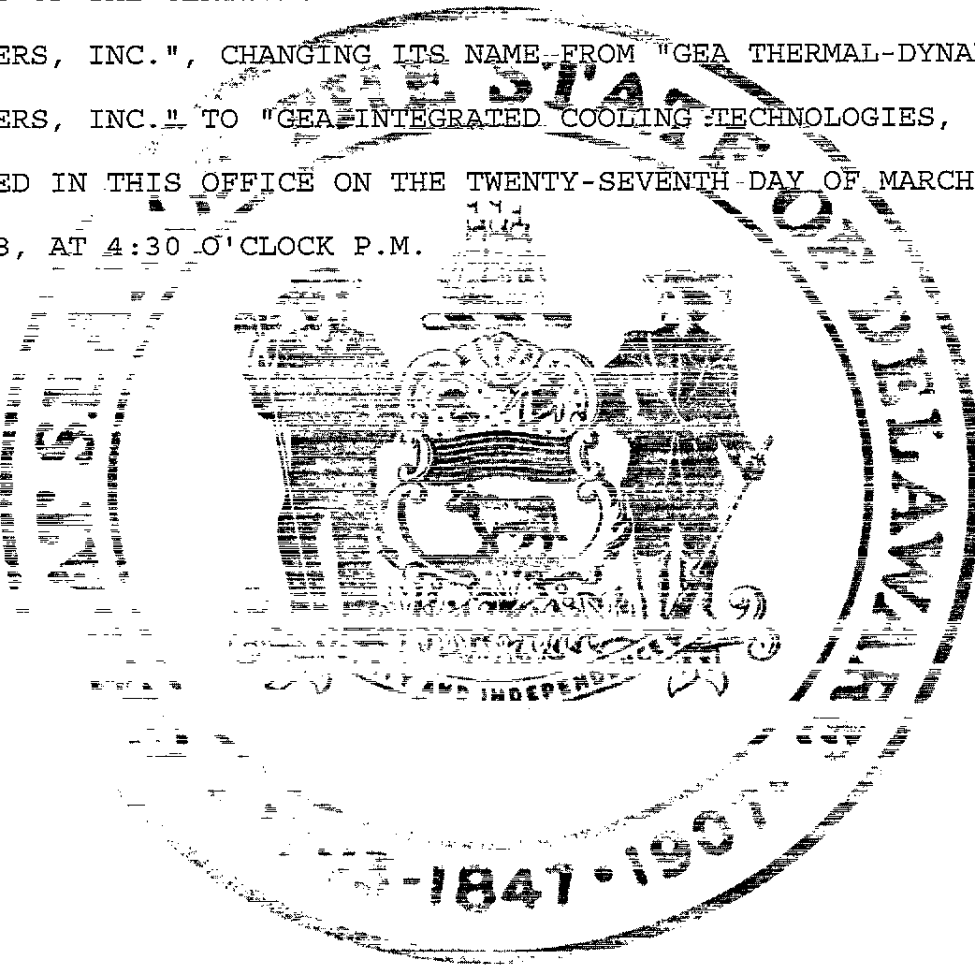

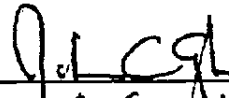
RESOLVED, that the Restated Certificate of Incorporation of corporation be amended by changing the First Article thereof so that, as amended, said Article shall be and read as follows:

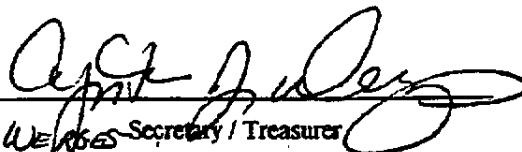
"the name of the corporation is GEA Integrated Cooling Technologies, Inc."
