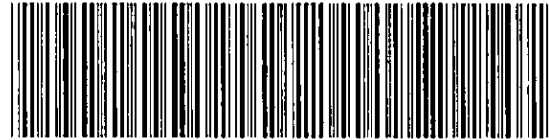

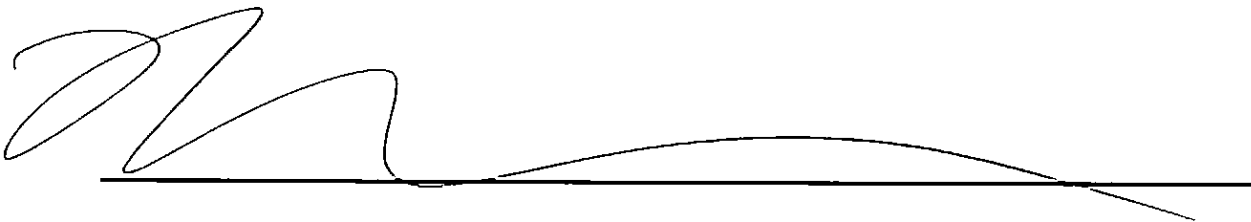

The Articles of Incorporation (the "*Articles*") for DBD Dental, Inc., a Florida corporation were filed on December 29, 2022 and assigned Florida document number P23000000029.

The Articles are hereby amended as follows:

1. Article I is hereby amended as follows:

**ARTICLE I - NAME:**

The name of this corporation is DBD Dental, P.A. (the "*Corporation*").

2. Article VI is hereby added to the Articles as follows:

**ARTICLE VI – PURPOSE:**

The Corporation is organized for the purpose of rendering professional services in the practice of dentistry and to render goods and services and engage in activities ancillary thereto.

The above amendments were adopted by the unanimous consent of the shareholders of the Corporation on February 17, 2023. The shareholders have elected to bring the Corporation within the provisions of the Professional Service Corporation and Limited Liability Company Act.
