ARTICLES OF INCORPORATION

OF

TRUE ABBEY HOLDINGS, Inc.

The undersigned incorporator, being competent to contract, subscribes to these Articles of Incorporation to form a corporation for profit under the Florida Business Corporation Act (the "Act").

ARTICLE 1. Name

The name of this Corporation shall be:

True Abbey Holdings, Inc.

ARTICLE II. Principal Office

ARTICLE III. Business and Activities

This Corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV. Capital Stock

- Section 1. Capital Stock. The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time is: (A) one thousand (1,000) shares of Common Stock, \$0.0001 par value per share (the "Common Stock").
- Section 2. Except for voting rights, as described in Section 3 of this Article IV, the Common Stock shall have all of the rights, preferences, privileges, and restrictions as set forth in the succeeding provisions of this Articles IV.

No committee of the Board of Directors may preempt the Shareholders' Agreement signed by all Shareholders.

This Corporation expressly elects not to be governed by the provisions of Florida Statutes Section 607.0901 dealing with affiliated transactions.
