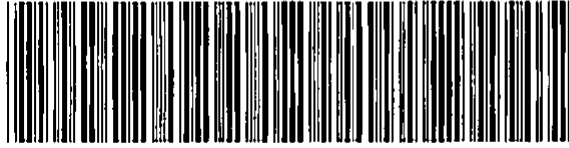

OF

ARTICLE I

The name of this corporation is 700 HOLDING CORPORATION (the "Corporation").

ARTICLE II
