ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

Article I
Name

The name of this corporation shall be BROWNING CONCIERGE MEDICINE, INC.

Article II
Principal Office and Mailing Address

Capital Stock

3.1. Capital Stock. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 7,500 shares of common stock.

Bylaws

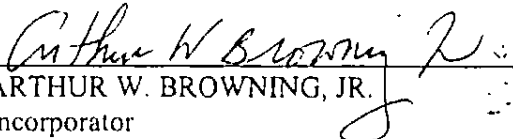

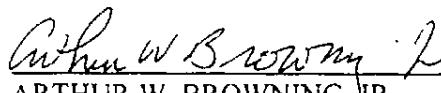
