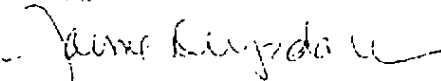
I recently filed for a corporation and accidentally spelled my name wrong (Jaime Drysdale PA P23000001774). I then filed for a corporation in my real name.
