ARTICLES OF INCORPORATION
OF
TRIDENT EQUITY INVESTMENTS, INC.

Pursuant to the filing of these Articles of Incorporation (these "*Articles*"), the undersigned hereby forms a Florida profit corporation under The Florida Business Corporation Act, Chapter 607, Florida Statutes (the "*Act*").

ARTICLE I
NAME

The name of the corporation is TRIDENT EQUITY INVESTMENTS, INC. (the "*Corporation*").

ARTICLE II
PURPOSE

The general purpose of the Corporation shall be the transaction of any and all lawful business.

ARTICLE III
PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office and mailing address of the Corporation is as follows:

ARTICLE IV
COMMENCEMENT OF CORPORATE EXISTENCE

ARTICLE V
SHARES

The number of shares which the Corporation shall have authority to issue is Ten Thousand (10,000), consisting of a single class of common stock, One Cent (\$0.01) par value per share.


