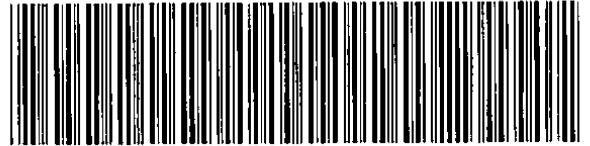

**Articles of Incorporation  
of  
Meanies Management, Inc.  
(a Florida corporation)**

Pursuant to Florida Statutes Section 607.0201 and Section 607.0202, the undersigned hereby submits the following Articles of Incorporation of **Meanies Management, Inc.**, a corporation being organized under the laws of the State of Florida.

**ARTICLE 1.**

**Name**

The name of the Corporation is "**Meanies Management, Inc.**" (hereinafter called the "**Corporation**").

**ARTICLE 2.**

**Purpose**


