# ARTICLES OF INCORPORATION OF WHITEHALL INVESTMENTS INC.

The undersigned, acting as incorporator of Whitehall Investments Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

### ARTICLE L. NAME

#### ARTICLE VIII. INCORPORATOR


