**ARTICLES OF INCORPORATION OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

**ARTICLE I  
NAME AND ADDRESS**

The name of the Corporation is Sigma Sunshine, Inc. The principal office and mailing address of the Corporation is 1430 Railhead Blvd., #107, Naples, FL 34110.

**ARTICLE II: DURATION**

The duration of the Corporation is perpetual.

ARTICLE X: INDEMNIFICATION

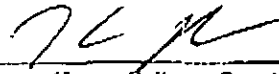

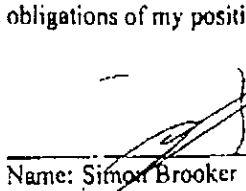
