**ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED, acting as sole incorporation of **FGMB HOLDINGS, INC.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I.
NAME**

The name of the corporation is **FGMB Holdings, Inc.**

The authorized number of shares which the corporation shall have the authority to issue is 99, consisting of a single class of common stock, par value \$0.01 per share.
