**ARTICLES OF INCORPORATION**  
**OF**  
**1-800-PACKOUTS OF CENTRAL FLORIDA, INC.**  
(a Florida corporation for profit)

The undersigned, for the purpose of forming a corporation for profit under the provisions of the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation.

**ARTICLE I**  
**NAME**

The name of this corporation is **1-800-PACKOUTS OF CENTRAL FLORIDA, INC.**

**ARTICLE II**  
**DURATION**

This corporation shall have perpetual duration. The corporate existence shall begin with the date and time of the filing of these Articles of Incorporation by the Florida Department of State.
