The undersigned, James Sater, hereby presents these Articles of Incorporation as the Articles of Incorporation for JAMES SATER INSURANCE AGENCY, INC. pursuant to Chapter 607, Florida Statutes.

**ARTICLE I - NAME**

The name of the corporation is James Sater Insurance Agency, Inc. This corporation is referred to in these Articles of Incorporation as the "Corporation."
