
I, Jody Sisk, of St. Augustine, in St. Johns County, Florida, MAKE OATH AND SAY THAT:



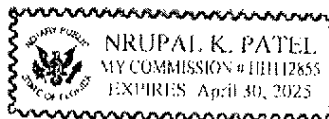
