**Section 2.01 Registered Agent and Registered Office**

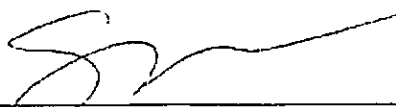

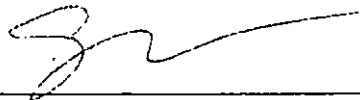
