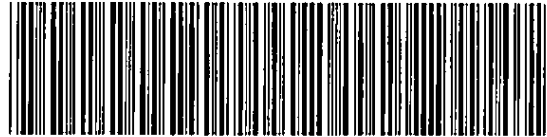

This corporation shall exist perpetually unless dissolved according to law.




