ARTICLES OF INCORPORATION OF AVIASUR CORP.

The undersigned, acting as incorporator of Aviasur Corp. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is Aviasur Corp. (the "Corporation").

ARTICLE II. ADDRESS

The principal and mailing address of the Corporation is 801 US Highway 1, North Palm Beach, FL 33408.

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the Corporation will commence on the date of filing of these Articles of Incorporation.

ARTICLE IV. PURPOSE

The Corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the Corporation is authorized to have outstanding at any time is 1,000 shares of common stock having \$0.01 par value per share.

The name and street address of the incorporator is Rodrigo Alonso Contreras Brain, 801 US Highway 1, North Palm Beach, FL 33408.


ARTICLE IX. BYLAWS
