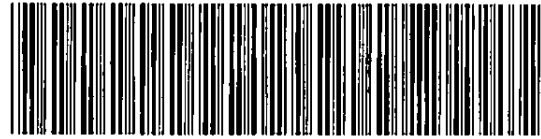

**ARTICLES OF INCORPORATION
OF

In compliance with the requirements of Florida Statute Chapter 621, the undersigned, being natural person, hereby acting as the Incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business professional service corporation.

ARTICLE I
