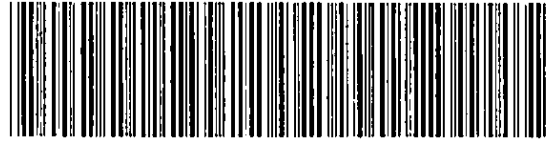



ARTICLES OF INCORPORATION
IN COMPLIANCE WITH CHAPTER 607, F.S.

ARTICLE I – NAME

The name of the corporation shall be Next Step Franchising, Inc. (the “*Corporation*”).

ARTICLE II – PRINCIPAL OFFICE

The principal place of business and the mailing address of the Corporation are: 711 5th Avenue South, Suite 210, Naples, FL 34102.

ARTICLE III – PURPOSE

The purpose for which the Corporation is organized is to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act (the “*FBCA*”).

ARTICLE IV – SHARES

The number of shares of capital stock of the Corporation is 200,000 shares of common stock, no par value (the “*Common Stock*”). 100,000 shares of the Corporation’s Common Stock shall be designated as “Series A Common Stock”, and the remaining 100,000 shares of the Corporation’s Common Stock shall be designated as “Series B Common Stock”. The holders of Series A Common Stock shall be entitled to one (1) vote for each share of Series A Common Stock then held on all matters presented to the shareholders of the Corporation for their vote or consent. To the fullest extent permitted by the FBCA, holders of Series B Common Stock shall not be entitled to vote on any matters presented to the shareholders of the Corporation for their vote or consent.

ARTICLE V – DIRECTORS AND/OR OFFICERS




