

ARTICLES OF INCORPORATION OF ECORTEX HOLDING, CORP.

In compliance with the requirements of Florida Statutes Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I NAME

The name of this corporation is Ecortex Holding, Corp.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address is c/o 1000 Brickell Avenue, Suite 400, Miami, Florida 33131.

ARTICLE III TERM OF CORPORATE EXISTENCE

This corporation shall exist perpetually unless dissolved according to law and such existence shall commence at the time of the filing of these Articles of Incorporation with the Secretary of State of Florida.

ARTICLE IV PERMITTED ACTIVITY

This corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now existion they hereafter be amended.

ARTICLE V AUTHORIZED SHARES

The aggregate number of shares which the corporation shall have authority to issue shall be One Thousand (1,000) shares of voting common stock with \$1.00 par value per share. All Common stock with \$1.00 par value per share.

Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE VI PREEMPTIVE RIGHTS
