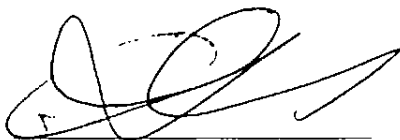

ARTICLES OF INCORPORATION
FOR
BACK ALIGNED CHIROPRACTIC, P.A.

The undersigned, acting as incorporator for this corporation pursuant to Chapter 621 of the Florida Statutes, who is duly licensed to practice as a chiropractor, hereby forms a professional service corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation:

ARTICLE I
NAME OF CORPORATION

The name of the corporation shall be **BACK ALIGNED CHIROPRACTIC, P.A.**

ARTICLE II
TERM OF EXISTENCE

This corporation shall begin its corporate existence as of the 28 day of April 2023, and shall exist perpetually.

ARTICLE III
GENERAL PURPOSE

The general purpose for which this corporation is organized shall be:
To render professional Chiropractic services to the general public, and all things in connection therewith that are customarily done by Chiropractors, under the laws of the State of Florida. The business of the corporation shall be limited to the foregoing activities.

ARTICLE IV
CAPITAL STOCK

The maximum number of shares of capital stock that this corporation is authorized to issue and have outstanding at any time is seventy-five thousand (75,000) shares of common stock having a par value of ten cents (\$0.10) per share.

ARTICLE V
SHAREHOLDER RESTRICTIONS

No one other than an individual who is duly licensed or legally authorized to render Chiropractic services in the State of Florida may own stock of this corporation. No shareholder of this corporation shall enter into any type of agreement vesting another person with the authority to exercise the voting power of any or all of his stock. Any stockholder who becomes legally disqualified to render Chiropractic services shall sever all employment with and financial

interest in the corporation. No shareholder of the corporation may sell or transfer his stock in this corporation, except to another individual who is eligible to be a shareholder of the corporation.

ARTICLE VI
REGISTERED OFFICE, REGISTERED AGENT, AND PRINCIPAL OFFICE

The initial street address of the initial Registered Office of the corporation in the State of Florida will be 2933 Crystal Creek Boulevard, Orlando, FL 32837. The Board of Directors may, from time to time, move the registered office to any other address in Florida. The name of the initial Registered Agent at such address is Karlton Jiang Teim Kwan. The Board of Directors, from time to time, may designate a new registered agent.

The corporation shall indemnify any incorporator, officer, director, or any former incorporator, officer, or director, to the full extent permitted by law.

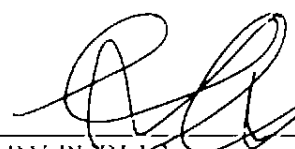

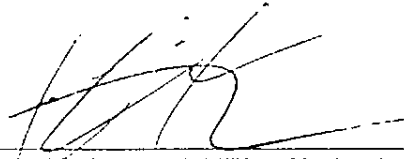
