OF

In compliance with the requirements of the Florida Business Corporation Act (the "FBCA"), the undersigned hereby acts as an incorporator in adopting and filing these Articles of Incorporation.

**ARTICLE I
Name**

The name of the corporation shall be Epstein Bared Founder Holdings, Inc. (the "Corporation").

**ARTICLE II
