ARTICLES OF INCORPORATION OF RXDEEX CONSULTING INC.

Pursuant to Chapter 607 of the Florida Statutes (the "Florida Business Corporation Aci"), the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I: NAME

The name of the corporation shall be RXDeeX Consulting Inc. (the "Corporation").
