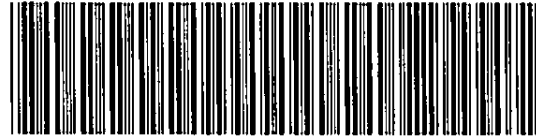



**ARTICLES OF INCORPORATION
OF
WHITEKNUT INVESTMENTS CORP.**

In compliance with the requirements of Florida Statutes Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I
NAME**

The name of this corporation is Whiteknot Investments Corp.

**ARTICLE II
PRINCIPAL OFFICE**

The principal place of business and mailing address is 21050 NE 38th Avenue, Unit 2403, Aventura, Florida 33180.

**ARTICLE III
TERM OF CORPORATE EXISTENCE**
