

Pursuant to Florida Statutes Section 607.1006, the undersigned hereby submits the following Second Articles of Amendment to the Articles of Incorporation of **SAO Family Holdings, Inc.**, a corporation being organized under the laws of the State of Florida.

- 1. The name of the corporation is SAO Family Holdings, Inc. (the "Corporation").
- 2. The Articles of Incorporation for the Corporation were filed with the Florida Department of State on June 13, 2023 (the "Articles of Incorporation"). The document number for the Articles of Incorporation is P23000045023. The Articles of Incorporation were subsequently amended by Articles of Amendment to Articles of Incorporation filed with the Florida Department of State on July 31, 2023 (the "First Amendment").
