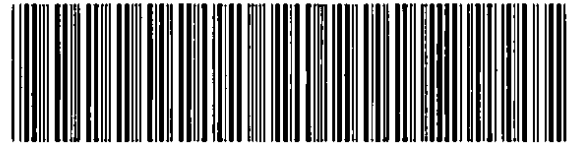




### ARTICLE VIII – EFFECTIVE DATE

### ARTICLE IX – AMENDMENT TO ARTICLES


