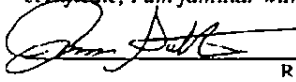

The total number of shares of all classes of stock which the Corporation shall have authority to issue is 100,000,000 of Shares, of which 50,000,000 shares of par value .01 per share shall be designated as Common Stock and 50,000,000 shares of par value .01 shall be designated as Preferred Stock.
