ARTICLES OF INCORPORATION

The undersigned Incorporators, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be:

ARTICLE III: NATURE OF BUSINESS - PURPOSE


ARTICLE XV: I.R.C. SECTION 1244 STOCK


