ARTICLES OF INCORPORATION  
OF

The undersigned hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation in accordance with the laws of the State of Florida.

ARTICLE I  
Name and Principal Office

The name of the corporation shall be Greenlife Industries, Inc. The principal office address and mailing address of the corporation shall be 6551 Industrial Avenue, Port Richey, Florida 34668.

ARTICLE II  
Term of Existence

The corporation shall have perpetual existence, commencing on July 7, 2023.

ARTICLE III  
Purpose

The general purpose of the corporation shall be to transact any and all lawful business for which corporations may be incorporated under Florida law.

ARTICLE IV  
Powers

The corporation shall have all powers conferred by the laws of the State of Florida upon corporations.

ARTICLE V  
Capital Stock

Registered Office and Agent

The corporation shall initially have one (1) director. The number of directors may be increased or decreased from time to time by the shareholders, provided that the corporation shall always have at least one director. The shareholders of the corporation may remove any director from office at any time with or without cause.

Any director or officer may be a member, may be a party to, or may have a monetary or other interest in any contract or transaction of the corporation, provided that the fact that he is so interested shall be disclosed or shall have been known to the Board of Directors. Any director or officer of the corporation who is also a director or officer of such other corporation or member of such firm, or who is so interested, may be counted in determining the existence of a quorum at any meeting of the Board of Directors of the corporation which shall authorize any such contract or transaction, with like force and effect as if he were not such officer or director of such other corporation or member of such firm, or not so interested.

Bylaws



(b) The bylaws of the corporation shall be for the government of the corporation and may contain any provisions or requirements for the management or conduct of the affairs and business of the corporation, provided that the bylaws are not inconsistent with the provisions of these Articles of Incorporation or contrary to the laws of the State of Florida or of the United States.




