OF

ARTICLE I
NAME AND ADDRESS

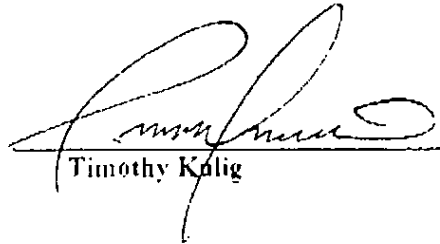
