**ARTICLES OF INCORPORATION**

The undersigned, for the purpose of creating a professional service corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

**ARTICLE ONE**  
**CORPORATE NAME AND PRINCIPAL OFFICE**

The name of the corporation is **JACOB K. HAWKINS, M.D., P.A.** ("Corporation") and its principal office and mailing address is 1034 Mar Walt Drive, Suite 100, Fort Walton Beach, Florida 32547.

**ARTICLE TWO**  
**NATURE OF BUSINESS**

The nature of the business to be transacted by the Corporation shall be to engage in every aspect in the practice of medicine and all its related fields and specializations, as are engaged in by **JACOB K. HAWKINS, M.D.** The professional services rendered by the Corporation may be rendered only through individuals duly licensed to render professional medical services under the laws of the State of Florida. The Corporation shall not engage in any business other than the rendition of the professional medical services specified herein. However, the Corporation may invest its funds in real estate, mortgages, stocks, bonds or any other type of investment and may own or lease real and personal property necessary for the rendering of the specified professional medical services.

No shareholder of the Corporation shall enter into a voting trust agreement or other type of agreement vesting any other person with the authority to exercise the voting power of any or all of his/her shares of common stock of the Corporation.

**CAPITAL STOCK**
