ARTICLES OF INCORPORATION OF TRINITY DEVELOPMENT INITIATIVE, INC.

A Florida Corporation

The undersigned incorporator submits the following Articles of Incorporation for Trinity Development Initiative, Inc. (the "Corporation") under Chapter 607, Florida Statutes, the Florida Business Corporation Act (the "Act"):

ARTICLE 1 NAME
