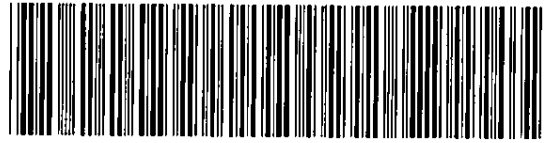

**ARTICLES OF INCORPORATION
OF
ACQUAVELLA PB, INC.**

In compliance with the requirements of the Florida Business Corporation Act (the "FBCA"), the undersigned hereby acts as an incorporator in adopting and filing these Articles of Incorporation.

**ARTICLE I
Name**

The name of the corporation shall be Acquavella PB, Inc. (the "Corporation").

**ARTICLE II
Principal Office**

The street and mailing address of the principal office is 340 Royal Poinciana Way, Suite M309, Palm Beach, Florida 33480.

**ARTICLE III
Registered Office and Agent**

The street address of the initial registered office of the Corporation is 1200 South Pine Island Road, Plantation, FL 33324. The name of the initial registered agent of the Corporation at that office is CT Corporation.

**ARTICLE IV
Purpose**

The purpose of the Corporation is to engage in any lawful act or activity for which a corporation may be incorporated pursuant to the Act.

**ARTICLE V
Shares**

The total number of shares that the Corporation is authorized to issue and have outstanding at any time is 100, all of which shall be common stock with a par value of \$0.01.

Any repeal or modification of this Article IX by the shareholders of the Corporation will be prospective only and will not adversely affect any limitation on the personal liability of a director of the Corporation existing at the time of such repeal or modification.
