Smart Transportation Gateway Corp.

The total number of shares of all classes of stock which the Corporation shall have authority to issue is 200 of which 100 shares of par value \$1.00 per share shall be designated as Common Stock and 100 shares of par value \$1.00 shall be designated as Preferred Stock.
