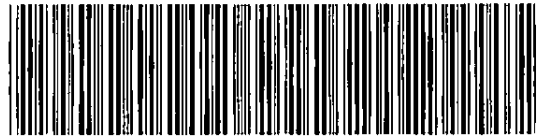

ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation shall be:

BARTRAM ELECTRIC SERVICES, INC.

The general nature of the business to be transacted by this corporation is:

To engage in services and activities associated with decision-making in the public and private sector.

These Articles of Incorporation shall be effective the date of filing.


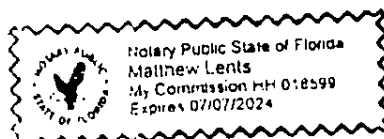
