FOURTH: The mailing address of the Registered Office of the Corporation is 4900 Bridgehampton Boulevard, Sarasota, Florida 34238.

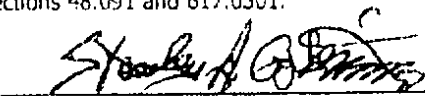

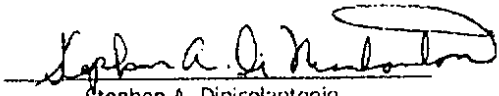
