# ARTICLES OF INCORPORATION OF JUMP PROPERTY, CORP.

Pursuant to the provisions of Chapter 607 of the Florida Statutes (the "Florida Business Corporation Act"), the undersigned incorporator, for the purposes of forming a Florida profit corporation, hereby adopts the following Articles of Incorporation:

#### ARTICLE I NAME

The name of the corporation is Jump Property, Corp. (the "Corporation").

### ARTICLE 2 DURATION, PLACE OF BUSINESS AND MAILING ADDRESS

The period of duration of the Corporation is perpetual and its principal place of business is located at 5151 Collins Ave, Unit 1527, Miami Beach, FL 33140. The Corporation is authorized to provide indemnification of its agents (as defined in Section 607.0851 of the Florida Business Corporation Act) through bylaw provisions, agreements with agents, vote of shareholders or disinterested directors or otherwise, subject to the applicable limits set forth in Section 607.0850(7) of the Florida Business Corporation Act with respect to actions for breach of duty to the corporation and its shareholders.

8.1. Any repeal or modification of the foregoing provisions of this Article 8 shall not adversely affect any right or protection of a director or agent of the Corporation existing at the time of such repeal or modification.
