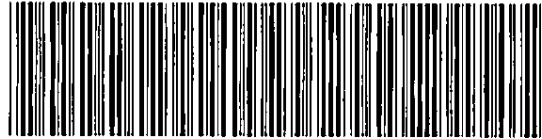

OF

ARTICLE I

The name of the corporation is ALFA VENTURES CORP. (hereinafter called the "Corporation").
