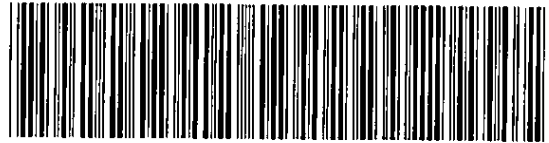

ARTICLES OF INCORPORATION
OF

I, the undersigned, hereby file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit pursuant to the laws of the State of Florida.

Name and Address

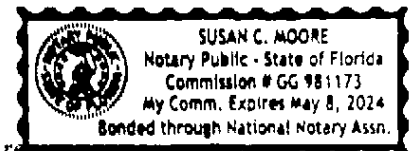
