ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF Data Factory Invest Inc.

Pursuant to Section 607.1006 of the Florida Business Corporation Act (the "FBCA"), Data Factory Invest Inc., a Florida corporation (the "Corporation"), hereby amends ("Articles of Amendment") its articles of incorporation, as amended (the "Articles of Incorporation"), as follows:

- 1. Upon the effectiveness of these Articles of Amendment pursuant to the FBCA (the "Effective Time"), each share of the Corporation's common stock, no stated par value per share (the "Common Stock"), shall automatically and without any action on the part of the holder thereof be subdivided and reclassified such that each share of Common Stock issued and outstanding as of the Effective Time (collectively, the "Pre-Split Common Stock") shall become one thousand (1,000) shares of Common Stock (i.e., a 1,000-for-one forward stock split), with any fractional shares of Common Stock (the "Forward Split"). Each certificate that immediately prior to the Effective Time represented shares of Pre-Split Common Stock ("Old Certificates"), shall thereafter represent that number of shares of Common Stock into which the shares of Common Stock represented by the Old Certificate shall have been reclassified as a result of the Forward Split. The number of authorized shares of Common Stock, and the par value per share of Common Stock, shall not be affected by the Forward Split.
- 2. These Articles of Amendment shall become effective on filing with the Secretary of State of the State of Florida.
- 3. These Articles of Amendment were duly adopted in accordance with Section 607,1001 and Section 607,10025 of the FBCA. The Board of Directors of the Corporation duly adopted resolutions setting forth and approving these Articles of Amendment. Pursuant to the provisions of Section 607,10025 of the FBCA, the approval of the shareholders of the Corporation was not required.
