The total number of shares of all classes of stock which the Corporation shall have authority to issue is 22,000,000 of which 20,000,000 shares of par value \$.001 per share shall be designated as Common Stock and 2,000,000 shares of par value \$.001 shall be designated as Preferred Stock.
