ARTICLE I

The name of the corporation is **ALINEA HAIR USA INC.**

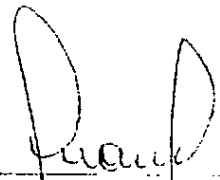
ARTICLE VII
