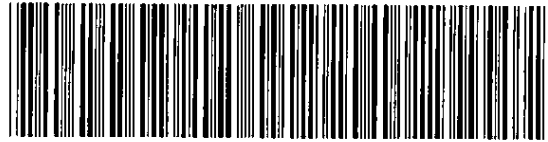

**ARTICLES OF INCORPORATION

In compliance with the requirements of Florida Statute Chapter 605, the undersigned, being natural people, hereby act as Incorporators in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I


