**ARTICLES OF INCORPORATION
OF
VETERAN SOLUTIONS OF NWF, INC.**

In compliance with the requirements of chapter 607, Florida Statutes, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation is Veteran Solutions of NWF, Inc. ("Corporation").

ARTICLE II

The existence of the Corporation shall begin on the date of filing and shall be perpetual.

ARTICLE III

The mailing address and the street address of the principal office of the Corporation is 530 Rio Ranchero Rd., Defuniak Springs, Florida 32433.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 100, par value \$1.00 per share, all of which shall be Common Shares.
