

FLORIDA ARTICLES OF INCORPORATION OF CELLULOSE ELDORADO USA, INC.

In compliance with the requirements of the Florida Business Corporation Act (the "FBCA"), the undersigned hereby acts as an incorporator in adopting and filing these Articles of Incorporation.

- 1. <u>Name.</u> The name of the corporation shall be Cellulose Eldorado USA, Inc. (the "Corporation").
- 2. <u>Initial Principal Office</u>. The street and mailing address of the initial principal office of the Corporation is 1815 Griffin Road, Suite 302, Dania Beach, Florida 33004.
- 3. <u>Purpose</u>. The Corporation is organized to transact any or all lawful business for which corporations may be incorporated under the FBCA as it now exists or may hereafter be amended or supplemented.
- 4. <u>Shares</u>. The total number of shares that the Corporation is authorized to issue and have outstanding at any time is one thousand (1,000), all of which shall be common stock with no par value. Each share of stock shall have one vote on all matters coming before the shareholders of the Corporation.

representative, is or was a director or officer of the Corporation or, while a director or officer of the Corporation, is or was serving at the request of the Corporation as a director, officer, employee, or agent of another corporation or of a partnership, joint venture, trust, enterprise, or nonprofit entity, including service with respect to employee benefit plans, against all liability, damages, and loss suffered and expenses (including attorneys' fees) actually and reasonably incurred by such Covered Person. Any amendment, repeal, or modification of this Article VII shall not adversely affect any right or protection hereunder of any person in respect of any act or omission occurring prior to the time of such repeal or modification.

8. <u>Effective Date and Time</u>. The effective date and time of these Articles of Incorporation shall be 12:01 AM on October 1, 2023.
