I was just referred to you by a helpful member of your team, and we are grateful for your assistance.

On March 29, 2023, our business affiliate submitted Articles of Organization for "Airmeez LLC" March 29, 2023 thinking our entity would become an LLC. (Doc # L23000158051 attached).

On August 3, 2023, we decided to become a corporation under the name as "Airmeez Inc." instead of "Airmeez LLC", and submitted Articles of Dissolution for "Airmeez LLC". (Doc #W23000107062 attached).

On August 7, 2023, we were advised in an email that the name "Airmeez Inc." was not available due only to the technicality of the 120 day waiting period for the reuse of entity names by unaffiliated principals.
