



ARTICLES OF INCORPORATION

OF

US MANUFACTURING HOLDINGS INC.

Pursuant to the Florida Business Corporation Act, Chapter 607, Florida Statutes, the undersigned incorporator US MANUFACTURING HOLDINGS INC., a Florida corporation (the "Corporation"), hereby adopts the following Articles of Incorporation for the Corporation:

ARTICLE I NAME AND PRINCIPAL & MAILING ADDRESS

The name of the Corporation is US MANUFACTURING HOLDINGS INC. The Corporation's initial principal office and mailing address is 10800 Biscayne Blvd., Suite 700, Miami, FL 33161.

ARTICLE II PURPOSE

The general nature of the business to be transacted by the Corporation shall be to have and exercise all powers conferred by the laws of Florida upon profit corporations, and to do any and all things hereinabove set forth to the same extent as a natural person might or could do. The Corporation shall have perpetual existence, commencing upon the filing of these Articles of Incorporation.
