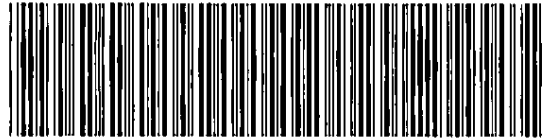

The undersigned does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of Chapter 607 Florida Business Corporation Act.

**Article I**

**The Name of the Corporation**

The name of the corporation (which is hereinafter referred to as the "Corporation") is:
