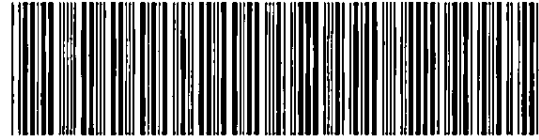

Pursuant to Florida Statutes Section 607.0201 and Section 607.0202, the undersigned hereby submits the following Articles of Incorporation of **Parker Davis Holdings, Inc.**, a corporation being organized under the laws of the State of Florida.

**ARTICLE I.  
Name**
