Great Northern Insured Annuity Corporation ("GNIAC") merged with and into General Electric Capital Assurance Company ("GECA") on January 1, 1999. For this reason, the 1999 Annual Report was not filed. On April 14, 1999, after receiving Document #P23150, Profit Corporation Annual Report 1999, I called the Florida Department of State to seek advice pertaining to this filing. I was told we are not required to file this annual report because of the merger.
